# Mackay community consultation—*Improving sustainable housing in Queensland*

### **Purpose**

To advise the Department of Infrastructure and Planning is holding a community consultation meeting on 9 July 2008 and visiting a shopping centre on 10 July 2008 in Mackay to seek public comment on the *Improving sustainable housing in Queensland* discussion paper.

### **Background**

<u>Building Newsflash 320</u> advised the public consultation process for the *Improving sustainable housing in Queensland* discussion paper has commenced. The discussion paper provides Queensland residents with the opportunity to have their say on a range of suggested sustainable housing improvements proposed by the Queensland Government. The proposed improvements will help make Queensland homes more naturally comfortable, use less water and energy and assist residents in making an informed decision about sustainable housing features when they buy or rent. A range of measures for new and existing homes are included in the discussion paper.

The Honourable Stirling Hinchliffe MP, Parliamentary Secretary to the Deputy Premier and Minister for Infrastructure and Planning will attend the community consultation session on Wednesday 9 July 2008.
