Forms 1–10:

 reflecting the machinery of government changes from the former Department of Local Government, Sport and Recreation to the Department of Infrastructure and Planning

Forms 21-24 and 26-35

- reflecting the new logo identity recently adopted by the Plumbers and Drainers Board (the Board)
- the provision of explanatory notes to clarify licensing requirements and Board policy
- the removal of nominated licensing application fees from relevant application forms to ensure future fee increases do not supersede the contents of those forms
- a schedule of fees notice has also been introduced to accompany relevant licensing application forms providing details of current application fees. This notice is also available on the department's website.
