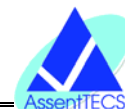

## COURSE ENROLMENT FORM

### **CANCELLATION & REFUND POLICY**

A full refund of enrolment fees will be made if a course is cancelled by AssentTECS for any reason.  
 An application for refund of course fees under any other circumstance must be made in writing to AssentTECS.  
 An eighty five percent (85%) refund is available up to ten working days prior to the commencement of the course.  
 Cancellation of enrolment under these circumstances will incur a fifteen percent (15%) administration fee.  
 No refund is available where cancellation is made less than ten (10) working days prior to the commencement of a course, or to participants who leave before finishing the course.  
 Refunds will be considered on a pro-rata basis for students who fall ill or are injured to the extent that they can no longer undertake the course providing a supporting Medical Certificate is supplied to AssentTECS.  
 However, should participants wish to finalise incomplete units of competency in a future course, the original fee can be used as a credit towards that course within six months of initial payment.  
 In all other cases, refunds are at the discretion of the Principal Consultant of AssentTECS and may be negotiated on an individual case-by-case basis.
