



ADDRESS OF YOUR HOUSE:

The Department of Housing and Public Works determines eligibility for Household Resilience Program grants using a number of factors including the amount of your household income and assets.

The Income Confirmation Service allows the Department of Housing and Public Works to obtain income and asset details for applicants directly from the Australian Government Department of Human Services. If you are in receipt of a Centrelink income, your consent on this form will allow the Department of Housing and Public Works to obtain your income and assets details directly from Australian Government Department of Human Services and use these to assess your eligibility for a grant.

Income Confirmation Service Consent

I, the undersigned authorise the Department of Housing and Public Works to use Centrelink Confirmation eServices to perform a Centrelink enquiry of my customer details and concession card status in order to enable the Department of Housing and Public Works to assess my entitlement to a grant. I authorise the Australian Government Department of Human Services to provide the results of that enquiry to the Department of Housing and Public Works.

I understand the Australian Government Department of Human Services will disclose personal information to the Department of Housing and Public Works including, where relevant, current and historical details of name, address, concession card status, payment type, payment status, one off payment, income, assets, deductions, shared care arrangements and partner status to confirm my eligibility for a Household Resilience Program grant.

I understand that this consent, once signed, remains valid only for the period that my grant application is being administered by the Department of Housing and Public Works. I understand that this authority, which is ongoing, can be revoked at any time by contacting the Department of Housing and Public Works or the Australian Government Department of Human Services.

I understand I can get proof of my circumstances/details from the Australian Government Department of Human Services and provide it to the Department of Housing and Public Works so that eligibility for a Household Resilience Program grant can be determined. If I withdraw my consent or do not alternatively provide proof of my circumstances/details, I may not be eligible for a Household Resilience Program grant provided by the Department of Housing and Public Works.
